FEBRUARY 12, 2025

The Mayor and Board of Alderman of the Town of Mansura met on Monday, February 12, 2025, at six o'clock. The meeting opened with a prayer and the Pledge of Allegiance.

Due to Mr. Thomas David not making the meeting, Mr. Rhett Desselle from Pan American Engineers presented the Mayor and Board of Alderman with some updates on water system improvements, Splash Pad, and Bayou Lacombe.

Motioned by Judy Bazert, seconded by Glenn McKinley and unanimously carried to accept and adopt resolution for "Substantially Completed" the work under the contract as recommended by the engineer for Water System Improvements.
