TOWN COUNCIL MEETING  
NOVEMBER 18, 2024

The Mayor Pro-Tempore and Board of Alderman of the Town of Mansura met on Monday, November 18, 2024, at six o'clock.

The meeting opened with a prayer and Pledge of Allegiance.

Motioned by Glenn McKinley, seconded by Judy Bazert and unanimously carried to add Resolution to the agenda for Waste Water System Improvements (Water Sector).
