The Mayor and Board of Alderman informed Mrs. Augustine that the Pavilion is not to be rented out for graduation parties per ordinance.


Mayor Pickett informed the Board of Alderman about the 50th year Knights of Peter Claver Mass on Sunday March 16, 2025, at 11:30am.


